STAR MICRONICS CO., LTD. ("the Company") today announced that it had decided to liquidate and dissolve its consolidated subsidiary Shanghai S&E Precision Co., Ltd. at a Board of Directors' meeting held on August 9, 2019. Brief details are presented as follows.

1. Reason for Liquidation

Positioned as a consolidated subsidiary in the Company's Precision Products Segment, Shanghai S&E Precision Co., Ltd. was established in April 2001 to engage in the manufacture of components for automobile, air conditioning equipment and other use. Shanghai S&E Precision has been forced to accept a request from its lessor to vacate and return its current base of operations by December 31, 2019.

Based on these current circumstances, and taking into account such wide-ranging factors as increasingly fierce price competition with local component manufacturers, the financial costs associated with relocating to another plant, and the prospect of increases in rent and personnel expenses in the future, STAR MICRONICS has decided to liquidate and dissolve Shanghai S&E Precision after recognizing the difficulties in continuing operations going forward.

4. Outlook

Losses associated with the liquidation and dissolution of Shanghai S&E Precision Co., Ltd. have been factored in as an extraordinary loss and posted as business restructuring expenses in the Company's consolidated results for the first half of the fiscal year ending December 31, 2019 announced on August 9, 2019. In addition, this matter will have nominal impact on the Company's consolidated financial results
