#### 2. Rationale for the revision

While the STAR MICRONICS Group anticipates that its operating results will be impacted by the slump in economic activity attributable to COVID-19, the degree to which earnings will be affected is difficult to reasonably estimate at this time. With its outlook yet to be determined, the Company has decided to temporarily withdraw its earnings forecasts announced on February 13, 2020. Details will be disclosed when an estimate becomes possible.

### **3.Response to and status of COVID-19**

The STAR MICRONICS Group undertakes various measures to ensure the health and safety of its employees and other related parties as a priority. In addition to promoting staggered working hours and telecommuting at each of its operating locations, the Group implemented such measures as the wearing of masks, the use of disinfectants, and social distancing at employee cafeterias and meeting rooms.
