設備投資額・減価償却費(年間) / Annual Capital Expenditures, Depreciation



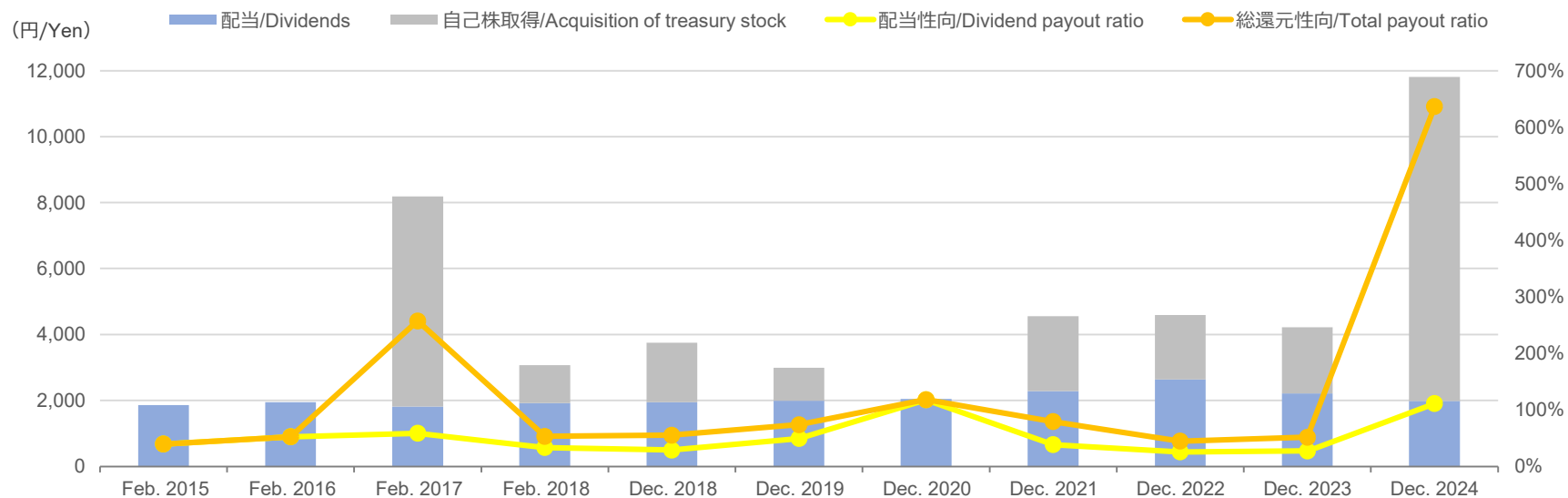

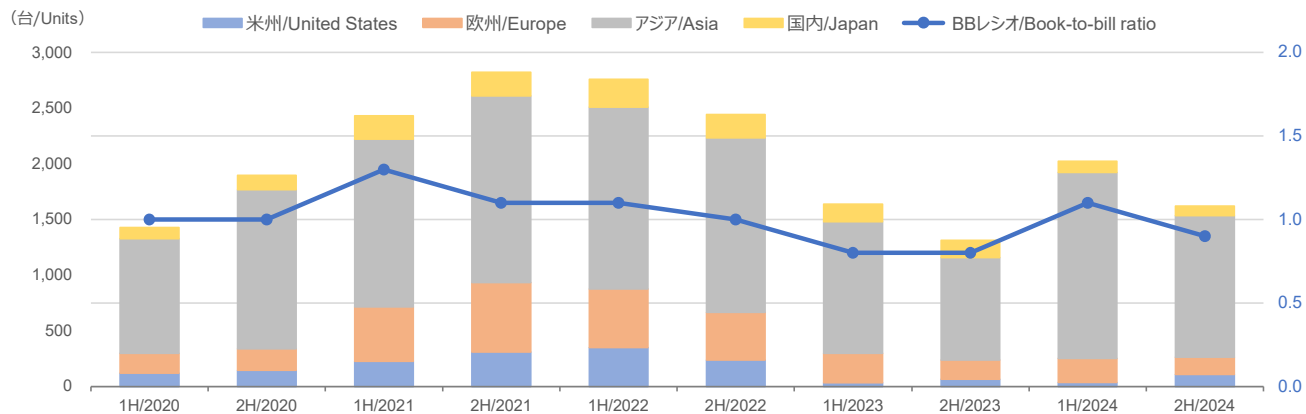

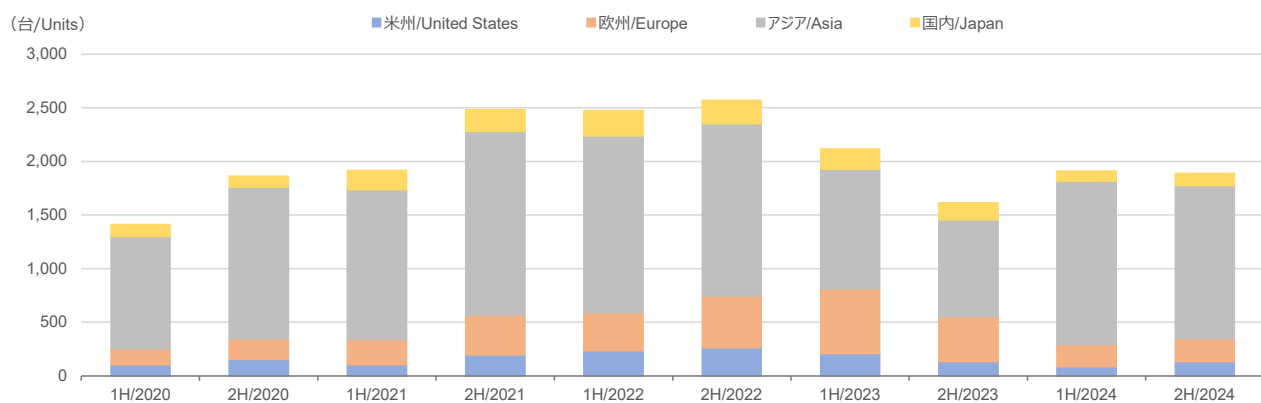

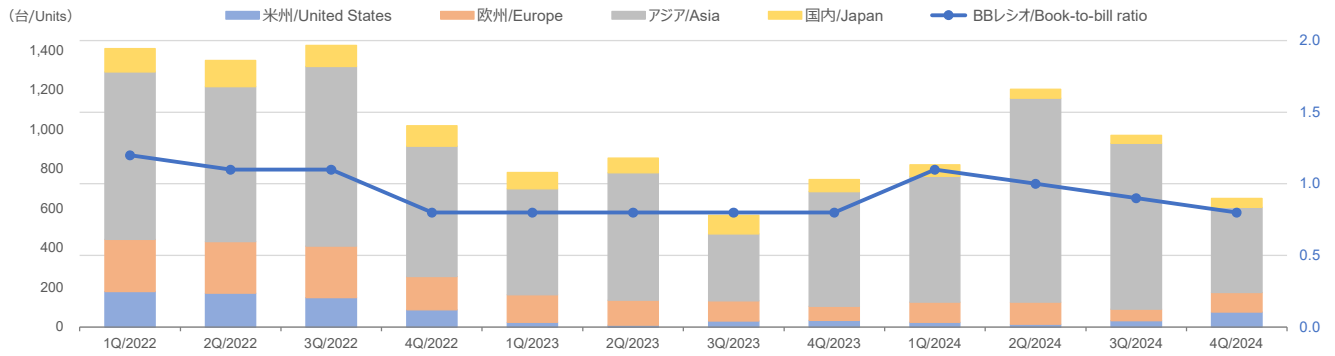

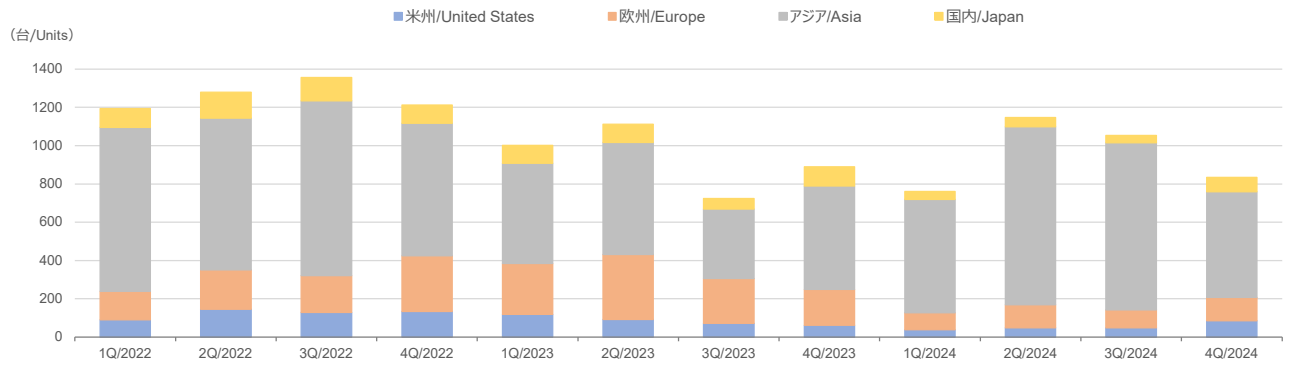

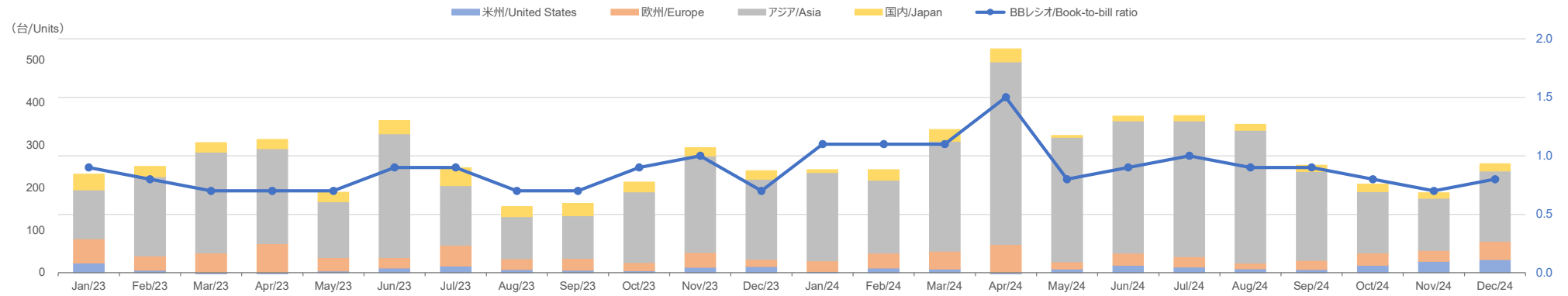

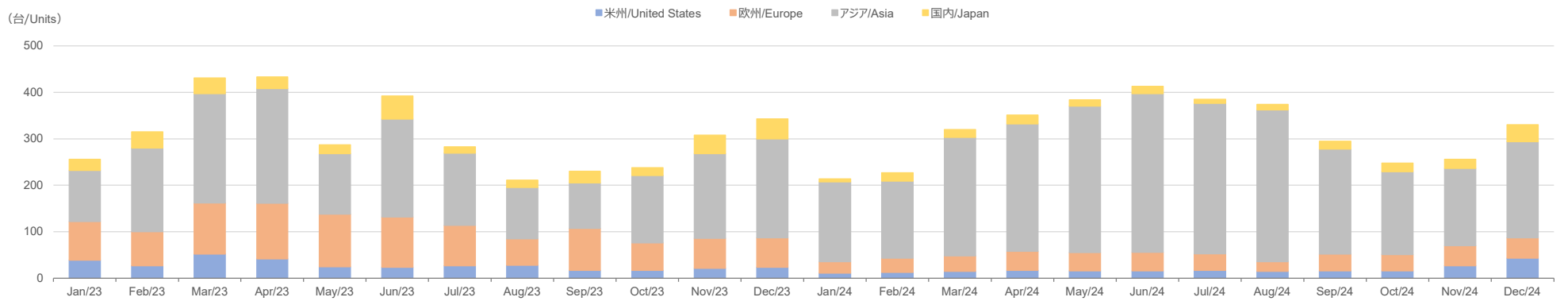

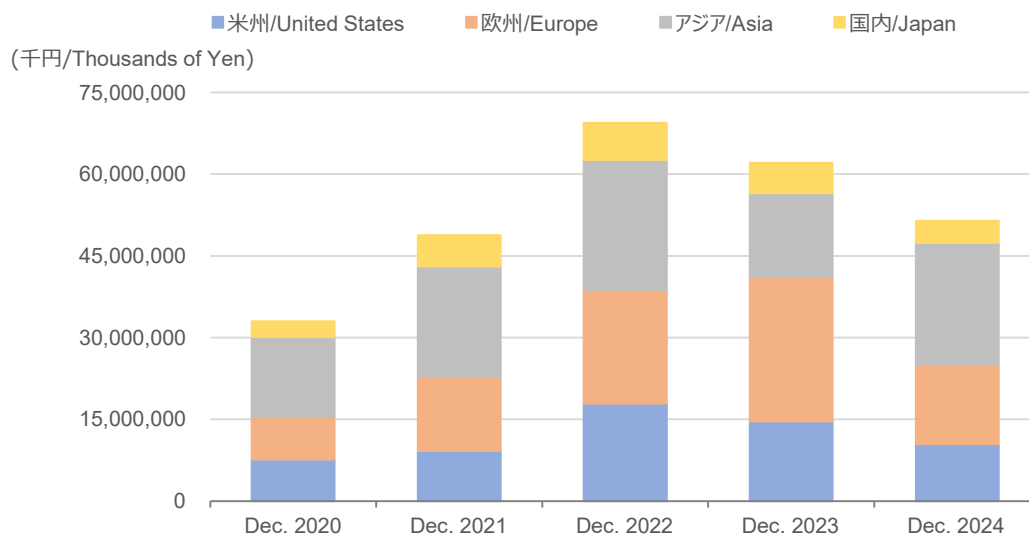

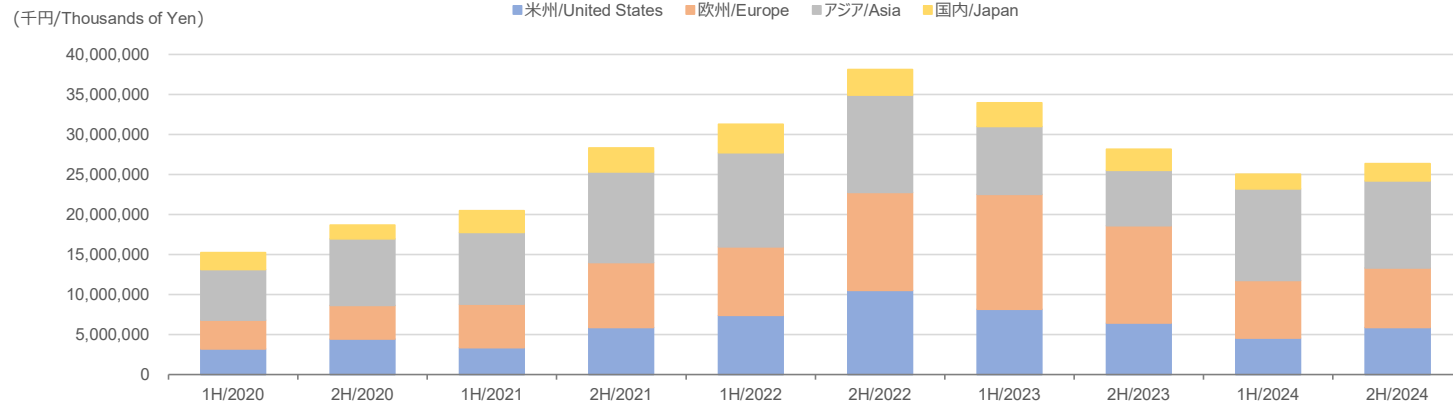

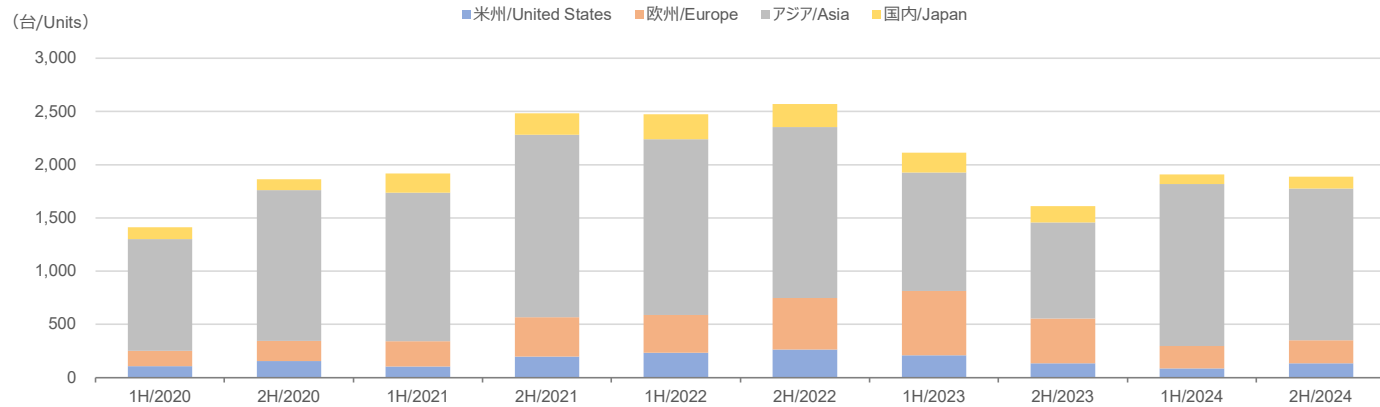

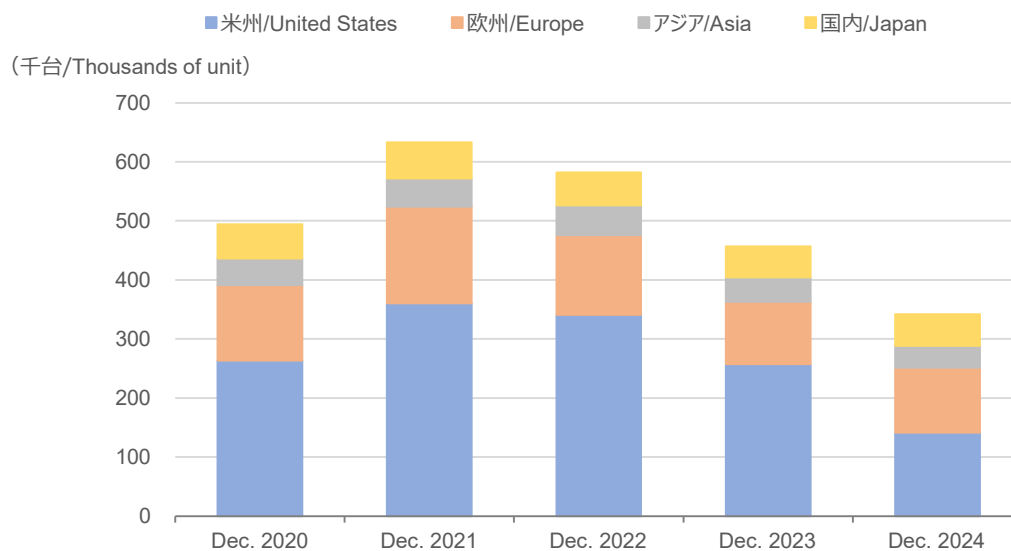

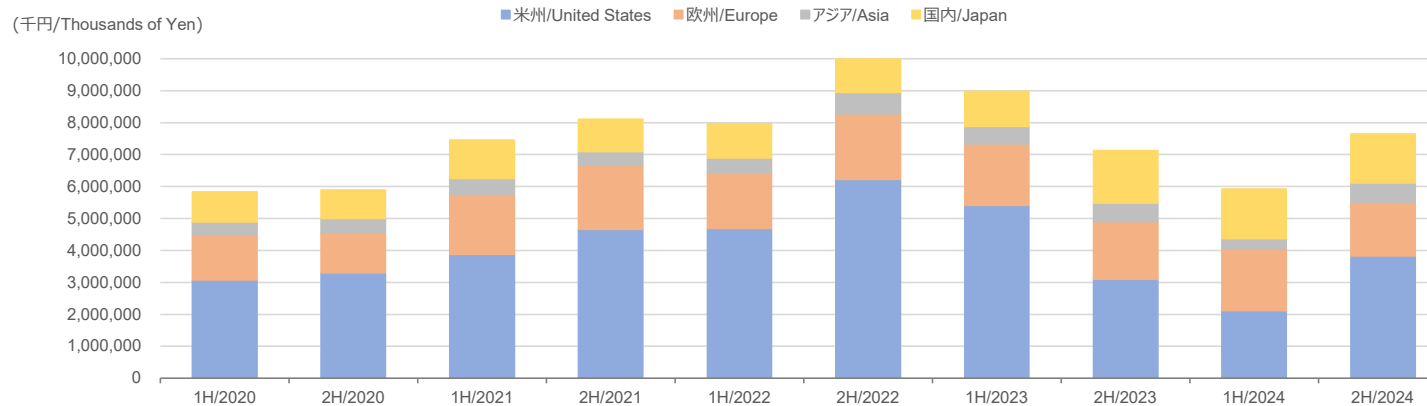
